Antonette Pelzer appeals her conviction and sentence in this case. The sentence was imposed by the Honorable Edgar W. Dickson on February 27, 2018. Antonette Pelzer was convicted by entering a guilty plea on February 27, 2018. The court ordered a five year sentence suspended upon time served, with probation for five years and ordered restitution in the amount of Three Thousand Dollars (\$3,000). The court further stipulated that probation could terminate upon full repayment of the restitution amount.


