
1. The initial brief of appellant and designation of matter in this case are due to be served and filed today having been extended by two prior orders of this Court.

Counsel filed the initial brief of appellant and designation of matter in the case of Wiley Sisk v. State in this Court on February 1, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jeron Alondo Cook v. State in the Supreme Court on January 22, 2018. Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Patrick Strozier in this Court on January 17, 2018.


3. This request is made in good faith, and not for purposes of delay.


