**BREACH OF TRUST**

That Carlon Weathers did in Spartanburg County on or about January 16, 2017, having been entrusted by the owners \_\_\_\_\_ and \_\_\_\_\_ Jones, with the care, keeping, and/or possession of certain property, described as follows: a black utility trailer valued at more than Two Thousand Dollars but less than ten thousand dollars, convert and/or appropriate such property to his or her own use and purposes, with the fraudulent intent to deprive the owner of the use thereof, in violation of §16-13-230 (B)(2) and 16-01-0057, THE CODE OF LAWS OF SOUTH CAROLINA (1976), as amended.
