This letter is to acknowledge that, on February 1, 2018, I received your letter dated January 29, 2018 requesting the Transcript of Record in the Gregory J. Feldman, et al v. Ray Thompson, et al., 2010-CP-42-5743 matter. I have reviewed my records and estimate that the transcript will be approximately 20 pages.


Rule 607 provides that the rate of \$3.25 shall be charged per page for a transcript. Based on the current rate, the estimated cost will be \$65.00. Upon receipt of your check in the amount of \$65.00, I will be able to place your request in line for typing. If the completed transcript is less than 20 pages, I will refund the difference to you upon delivery of the transcript. If the completed transcript is more than 20 pages, the balance will be due prior to delivery of the transcript.

Under our rules, I have 60 days in which to complete the transcript after receipt of the deposit. In addition, I am allowed to request from Court Administration 30-day extensions, if necessary, to complete the transcript. You will be notified if extensions are granted. If you would like to order the transcript expedited, receipt within 7 business days of deposit, the charge per page would be \$4.25, for a total of \$85.00 for an estimated payment.

If you desire to cancel the request for the transcript, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.




