**MOTION FOR THIRD EXTENSION OF TIME WITHIN WHICH

I.

Rowland; has submitted an Initial Brief of Respondent to the Supreme Court in Slocumb v. State; and has submitted an Initial Brief of Respondent to the Court of Appeals in State v. Hendricks, State v. Nixon, and State v. Moore.

III.




