Dear Ms. Brailsford:

Upon reviewing your appellant's final brief, the following deficiencies have been noted under the South Carolina Appellate Court Rules (SCACR), and each deficiency must be corrected within ten (10) days of the date of this letter or this appeal will be dismissed. Please also be advised that as of the date of this letter, we have not received a motion to file your appellant's final brief outside of the filing deadlines:

- The accompanying proof of service is not in compliance with the SCACR. Specifically, the proof of service provided states that you served the designation of matter. You must provide proof of service for the appellant's final brief. Your proof of service should be substantially in the format shown by Form 7 in Appendix C to part II of the SCACR.
- The title does not comply with Rule 267(a), SCACR. Specifically, the title of the document should read "Appellant's Final Brief," not "Initial Brief of Appellant."
- The document has not been signed as required by Rule 267(b), SCACR.
- The caption does not comply with Rule 267(a), SCACR. Specifically, the caption must match the one given below:

Seeahray Brailsford, Employee, Claimant, Appellant,

v.

Piggly Wiggly Carolina Company, Inc., Employer, and Constitution
State Service Company as TPA for Greenbax Enterprise Inc., Carrier,
Respondents.

- The document is not double spaced as required by Rule 267(c), SCACR.
- The content on pages 2-3, "Form 7" and "Form 13" cannot be filed as part of your appellant's final brief.
- You must serve and file an amended appellant's final brief in which all deficiencies have been corrected within ten (10) days of the date of this letter.
