**ORDER DENYING MOTION TO
RECONSIDER SENTENCE**

SC Court of Appeals


This matter came before me on December 4, 2017 by motion of Defendant's attorney, Bakari T. Sellers, who petitioned this Court for a reconsideration of sentence. The defendant was present alongside his aforementioned attorney. The State was represented by Assistant Solicitor Nicole M. Simpson of the Richland County Solicitor's Office.

The Court finds the following facts to exist in this case:

1. The Defendant was arrested on or about June 29, 2016 and charged with Contributing to the Delinquency of a Minor, CSC with Minor < 16 years of age 2nd degree, Promoting the Prostitution of a Minor (3 counts), and a Violation of Probation.
2. That the Assistant Solicitor made an offer to the Defendant prior to and after the scheduled date of trial.
3. That there was not a violation of the plea offer by the Assistant Solicitor in their request for a consideration for the higher end of the maximum sentence allowed.

THEREFORE, the Motion to Reconsider Sentence is DENIED.

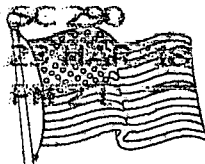
