
Wherefore, Appellant moves to request permission to order the transcript outside of the filing deadlines set by Rules 207. Should the Court grant this Motion, the Appellant's



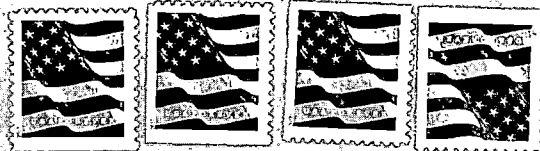
