

NOTICE OF APPEAL

The Appellant Resolute FP US, Inc. hereby notices its appeal of oral orders rendered by the circuit court on March 9, 2018. The first and primary order in question denied Resolute's motion for the circuit court to acknowledge and enforce the automatic stay created by a previous appeal by another defendant in this action, which decision affects Resolute's substantial rights and/or the mode of trial. The second order involved the denial of the Appellant's motions for relief based on the circuit court's lack of subject matter jurisdiction. The Appellant asserts that

the Court has jurisdiction to review all of these rulings on appeal, given the immediate appealability of the denial of the motion to enforce the automatic appellate stay.

The circuit court did not put the orders in writing and did not state any intention of doing so. Resolute received notice of the preliminary ruling on March 9, 2018.
