1 THE COURT: Okay. So they have admitted
2 headaches --

3 MR. JENKINS: Right.

4 THE COURT: -- so we're not here today to
5 determine whether or not there are any other body
6 parts related to your accident other than headaches,
7 so that's all they've admitted at this time.

8 MR. JENKINS: Right.

9 THE COURT: And I don't know if you're claiming
10 that you have more problems as a result of the
11 accident or not; I don't know. That's not why we're
12 here.

1 Defendants' Number 4 into evidence.

2 Q So you -- you're able to be on the computer
3 enough to send us a bunch of emails every week?

4 A I have to. I have to communicate with you
5 all.

6 Q You -- you tweeted an average of three times
7 a day over the last year?

8 A I'm going to object to that because I'll
9 have to verify that because now I have not seen that.

10 THE COURT: And I hear you, but the reason he can
11 submit this is one -- it's a public record, because if
12 you're on Facebook and you're on Twitter that's a
13 public record.

14 THE WITNESS: Right. Right. But the stuff that
15 I had is on public record. It's public record.

16 THE COURT: And that's all -- he's not submitting
17 anything that's not your --

18 THE WITNESS: Yeah.

19 THE COURT: -- because you just testified that
20 these are your accounts.

21 THE WITNESS: Right. But they -- but -- but
22 those -- Commissioner, those are public information
23 sent to me between me and Amazon, so -- so -- and so
24 if his information is going to be allowed, I think --
25 because I have not seen those before today. Those are

1 my email accounts.

2 MR. GOUDELOCK: You see those every day.

3 THE WITNESS: Wait a minute. We don't want to
4 get into -- we don't want to get it mixed.

5 THE COURT: No, but there's a difference between
6 an email exchange between somebody and what you put on
7 Facebook and Twitter. One's public domain and one's
8 private correspondence between you and another
9 individual.

10 THE WITNESS: No, I wouldn't -- I wouldn't
11 necessarily call them --

12 Q Let me ask -- let me ask again. Is -- is --
13 you're on Twitter, correct?

14 A I'm on Twitter.

15 Q That's your Twitter account; the documents
16 that I showed you?

17 A Right. But I'm not -- I'm not exactly sure
18 because I have not seen that document to review it --
19 properly review it.

20 Q You're welcome to look through it.

21 A But I -- well, I should have had it prior.

22 Q You want to look through it?

23 A Not today. It's too -- there's too many
24 documents --

25 Q Let me ask you this. So -- so you --

1 A I didn't get it prior to look at that.

2 Q -- you can email, you can tweet, I guess, is
3 that what you call it?

4 A Right. That's what you call it.

5 Q You can post on Facebook?

6 A Not that regular.

7 Q Huh?

8 A Not that regular on Facebook.

9 Q All right. During these days that you're
10 sending us these emails about all these problems you
11 have you -- you went to the rally at the State House
12 for South Carolina State thing didn't you?

13 A I did. I did.

14 Q All right.

15 A I did.

16 Q All right. You went to the Springfield
17 Democrats Rally?

18 A I did. I never said I was in -- not able to
19 move. I've always been very active and politically
20 involved in getting things, so. I don't do as much as
21 I used to, but I still do. And that's just honest. I
22 can do things like that.

23 Q You -- you can do things you want to do
24 can't you?

25 A No, I -- I already done said -- I have never

1 said to anybody at Amazon that I cannot work, and you
2 know that to be true because I went back to work.

3 Q Let me ask you - give me one second.

4 A I went to work --

5 Q Hang on one second.

6 A -- September to January -- September 2013 to
7 January 2014 and I was doing work then working an
8 entire shift, ten hours a night.

9 Q Okay. On the -- on the Twitter you -- you
10 talk a lot about the BMW thing, right?

11 A Right. Right.

12 Q Okay. You've -- you've been subject to
13 police brutality?

14 A Right.

15 Q You went to a trial on that and found
16 guilty?

17 A Well, since you want to bring that up, I
18 went to trial and they came back with a hung jury the
19 first time.

20 Q But then they -- they went back and they
21 came back with a guilty plea?

22 A No, because the judge -- the judge told them
23 --

24 Q The judge was against you?

25 A No, the judge -- the judge instructed them,

1 he said I told you all to come back with a unanimous
2 vote. But you know after that trial one of the
3 witnesses came by and she said, don't worry about it,
4 you were not guilty.

5 Q All right.

6 A So I guess she could have --

7 Q So with that you filed --

8 A But since you brought it up though I should
9 be allowed to explain what happened.

10 Q You filed a complaint with South Carolina
11 Human Affairs Commission?

12 A I did.

13 Q You went to Orangeburg County - Orangeburg
14 City Council about it?

15 A I did.

16 Q You filed a complaint with Orangeburg City
17 Police Department?

18 A I did.

19 Q All right. And you also were found to have
20 an altercation with the Orangeburg County Sheriff that
21 -- the sheriff's deputy?

22 A How long ago?

23 Q I don't know. You talked about it on your
24 Twitter Account. Said he called your Employer?

25 A That -- that's going back some --

1 Q Okay.

2 A No, no, no, I ought to be able to explain
3 it.

4 Q Okay.

5 A You talking about a situation that's going
6 back to 1996 I believe, where we had this longtime
7 sheriff. Y'all probably heard about it because he was
8 a nut case; James Preacher. Well, -- well he was one
9 of those like Boss Hogg in a small town, you know. So
10 anyhow, my brother got in a altercation with some guys
11 in the Town of Norway. I don't get involved in
12 foolishness. You can't bring it to me, I ain't
13 looking for it, I ain't going to hear it, so I didn't
14 know anything about it. I went to my aunt house
15 Thanksgiving eve just to spend some time with her and
16 her family. Well, all of a sudden that night, early
17 evening, I was just parked -- this police car came
18 around, didn't know who it was, shined a big bright
19 light into my car, couldn't see. He get out yelling,
20 getting out with his shotgun and my driver's window
21 wouldn't roll down, I had to talk to him through the
22 glass. Open the door, open the door, open the door.
23 So I said, I said, "What?" And so finally I opened
24 the door, he got me out, I was standing beside the
25 car. And he said, "I ought to take you" -- "I'm going

1 to take you down to Orangeburg County Jail. I'll make
2 you stay there until I get you out." I didn't -- I
3 didn't know anything about what had happened. So my
4 two cousins -- female cousins who were looking out the
5 window, they must have heard the commotion, they came
6 running out the house. So then he -- he didn't take
7 me to jail, he let me go. I went running in the
8 house, so that Monday he calls over to my Employer, I
9 worked at Aiken -- Aiken County Probation and Parole
10 Office, speaking to my -- my AIC, telling them that I
11 had been involved in a lynching in the community. Had
12 no knowledge of it whatsoever, none whatsoever. He
13 had articles in the newspaper -- local newspaper about
14 it, how he had arrested my brother. He called to
15 Columbia to the headquarters here in Columbia telling
16 stories. People in Orangeburg County were faxing
17 newspaper articles to my AIC. My AIC told him on --
18 in my phone -- I was in his office. He said he didn't
19 have any knowledge of it and if he did he did not have
20 the authority to arrest his brother. Call -- he
21 called up to Columbia to -- Columbia called down to
22 Aiken to my supervisor, had me rushed -- I flew up
23 here to Columbia. My supervisor must have been
24 driving about a hundred miles an hour, I'm fearing for
25 my life. Got to Columbia, they wanted to know what

1 happened in Norway. I said, "I don't" -- "I don't
2 know what happened in Norway." I said, I have a -- I
3 just told them I have a -- consulted legal counsel and
4 I'm not going to discuss this any further. And they
5 -- and they ended it. But I had nothing to do with --
6 but let me tell you about what happened to him before
7 he died. Since you wanted to bring that up, well, he
8 went on -- he lost his job in Norway, he went to
9 Ehrhardt, he was like a radical over there showing out
10 in front of the board meeting -- County Council
11 meeting and threatening people there. They got rid of
12 him. He came back to Norway, he wanted to be the
13 mayor and the chief of police. Got in trouble there.
14 Y'all probably saw this on the news where this highway
15 patrolman stopped him --

16 Q Okay.

17 A -- for -- for speeding and he turned around
18 -- but -- but -- but since you wanted to tell that --

19 Q You made your point.

20 A Right. No, no, no. He turned around after
21 the highway patrolman had arrested him and let him go,
22 he turned around and put his blue light on the highway
23 patrolman, and the -- the Attorney General of South
24 Carolina filed papers on him; he was arrested,
25 charged, he didn't go to court because he ended up

1 dying, had a heart attack back here a couple of years
2 ago.

3 Q Okay. On --

4 A But he was a tyrant.

5 Q -- on January 7th -- December -- December
6 7th of 2014, a couple of months ago, there's a tweet
7 that says "I am sleepy, therefore, will finish the
8 rest on tomorrow. A hard day's work for ten minutes,
9 but worth it. Good night and sleep tight." What's
10 that talking about?

11 A That's just having -- that's just having
12 some fun.

13 Q Were you working somewhere?

14 A No, I was just -- I was talking about
15 typing. I was talking about typing that Twitter
16 Account, that's what I was talking about.

17 Q Do you --

18 A No, I was -- I was talking about a tweet.

19 Q You had been -- you had been tweeting all
20 day?

21 A No, I was -- you're taking that out of
22 context. I was making some light humor on -- on
23 Twitter.

24 Q All right. And out of all those tweets that
25 you saw and your Facebook Account and sending us

1 emails every day about what's going on with you, none
2 of those tweets or Facebook posts mention anything
3 about you feeling bad do they?

4 A Well, that's not necessarily true, because
5 --

6 Q None of them talk about you can't see, none
7 of them talk about light bothers you, none of them
8 talk about you can't go anywhere. In fact you go
9 places. None of them talk about noise bothers you,
10 not mentioning any of those things.

11 A No, -- no, because when I'm on -- when I --
12 when I was doing Twitter I'm just having light
13 comments or I'm making social issues -- I'm making
14 comments about social issues in the world that might
15 have come on the news or TV, you know, just like other
16 people do. And then I also, the things with BMW
17 thing, I was trying to drum up support for people to
18 protest BMW by what had happened to me. And that's
19 how most people use Twitter and social media when they
20 have a situation, so I was just using what everybody
21 else used.

22 Q Okay. And you -- among the Facebook folks
23 you talk about -- you sent us an email a couple of
24 months ago about something that happened in church
25 where you were supposed to read the Scripture but you

1 couldn't read it?

2 A Right. I couldn't see.

3 Q Couldn't see?

4 A Couldn't see.

5 Q But you can see to tweet and you can see to
6 email us and you can see to Facebook?

7 A No, not -- not necessary. I've been looking
8 at something -- you know what, my eyesight problems it
9 comes and goes. I never said it was permanent, I said
10 it comes and goes. When it first happens --

11 Q It only -- it only comes when you're
12 emailing us?

13 A No, not necessary. When you look at my --
14 my Form 50 --

15 Q It goes --

16 A -- no, now wait a minute --

17 Q -- when you want to go to a rally and --

18 A No, no, no. If you look at my Form 50 that
19 was submitted back in February you can see where I
20 made a mistake. I'll get it. I'm going to get it for
21 you. I'm going to show you my eyesight problem. I
22 just -- I just noticed that today when I got here.

23 Q Yeah, I've got a copy.

24 A Yeah, but -- you see right here, 2015, look
25 where I had put a two here because I couldn't see the

1 two, I had eyesight problems. It comes and goes.

2 THE COURT: Mr. Jenkins, please take your seat
3 back.

4 A Oh. But that's a -- on the Form 50, where I
5 went ahead and put a two there because sometimes it
6 comes and goes.

7 Q What's -- what's Upscale Consulting?

8 A That was a company I was trying to start a
9 long time ago when the economy fell out and I was
10 unemployed. And because I was -- I consider myself an
11 expertise in Customer Service, I was trying to start
12 me own business probably back in --

13 Q 2010?

14 A No, I started that back in maybe -- well, it
15 could have been 2010 or 2009, but it was like early on
16 I wanted to start my own business. But it never did
17 get off the ground though.

18 Q Okay. You don't do anything with that now?

19 A No, huh-uh. I just use -- no, I haven't
20 done anything with that --

21 Q You use what?

22 A Well, I just use the name for my email
23 account, Upscale 81, but I haven't -- I never even got
24 that off the ground. Whenever I started I sent a few
25 packages out to seven different companies and no one

1 picked up on it so I kind of let that go.

2 Q All right. And you testified I think
3 earlier that you never had problems before, you didn't
4 have headaches before and all that kind of stuff?

5 A I've had headaches before, but I had never
6 had them to the point where they are now. I've --
7 I've had more with these headaches and nothing has
8 stayed with me this long and this often. I've had
9 problems with headaches.

10 Q You've had problems to the extent you
11 testified at an Employment Security Commission hearing
12 that you had headaches?

13 A That was a brief stint then, that was -- I
14 had never --

15 Q They asked you if you had any chronic
16 conditions and you said, "I wouldn't say chronic, but
17 I've had a lot of headaches in the past."

18 A Well, that was during that brief moment when
19 -- when -- at that moment -- that was in that brief
20 moment.

21 Q Kind of like your vision?

22 A No, well, I mean, I didn't say, I mean you
23 look at my medical record I -- you will -- you can't
24 -- there is no medical records of me being in a
25 hospital. You know, probably the last several years

1 there's no medical record of me going to a pharmacy
2 getting prescriptions, so I was pretty much a healthy
3 person up until this injury, and that can be proven.

4 MR. GOUDELOCK: Your Honor, that's all I have.
5 Thank you.

6 THE COURT: You can step down, sir. Thank you.
7 I appreciate it.

8 THE WITNESS: You're quite welcome.

9 THE COURT: Well, that will conclude -- do you
10 have anything more?

11 MR. GOUDELOCK: Nothing more, Your Honor.

12 THE COURT: Okay. Well, that will conclude this
13 proceeding. Mr. Jenkins, thank you for being here
14 today.

15 MR. JENKINS: I would like to question Ms.
16 Keisler, she worked for Amazon.

17 THE COURT: You can call her if you want to call
18 her.

19 MR. JENKINS: Okay. I'd like to call Ms.
20 Keisler. I see where Mr. Goudelock has some other
21 people down as witness. I don't see them here either.
22 He has Kelly Wells, he had my former -- one of my
23 former supervisor, Mike Sumina, he's not here either,
24 so I was just wondering what happened to them.

25 THE COURT: Well, he reserves the right to call

1 what witnesses he wants to as part of his defense.

2 MR. JENKINS: Okay. I'd like to call --

3 THE COURT: We're going to take a five minute
4 break real quick.

5 (Off the record at 5:31 p.m.)

6 (On the record at 5:42 p.m.)

7 THE COURT: We'll go back on the record.

8 MR. GOUDELOCK: Thank you, sir. I would object
9 to him calling Ms. Keisler, she was listed as my
10 witness. I didn't present her, he hasn't filed a
11 Prehearing Brief listing anybody as a witness, so I
12 think it's a bit improper for him to be able to call
13 her as part of his direct examination. She hasn't
14 been presented direct by me.

15 THE COURT: Okay. Mr. Goudelock is correct in
16 that, Mr. Jenkins. You didn't have any witnesses that
17 you wanted to present, Mr. Jenkins?

18 MR. JENKINS: No. I would -- well, I think -- I
19 think Ms. Keisler is more than able to testify. She's
20 been working with comp especially for Amazon, so she
21 has knowledge of a lot of things that is in his legal
22 Brief. So I -- I think she's -- you know, she's here.
23 You know even though she's here for the Defendants,
24 but she's here. And I ask the Court that he allow her
25 to testify.

1 MR. GOUDELICK: Same objection.

2 THE COURT: And I'm going to sustain Mr.
3 Goudelock's objection because he's correct in his
4 assessment about that and since you don't have anybody
5 else listed on yours and you made the point before we
6 left just a minute ago about individuals that he had
7 listed as witnesses are not here.

8 MR. JENKINS: Right.

9 THE COURT: That's his prerogative as to who, he
10 can list them as witnesses saying that he reserves the
11 right to call those individuals, but that does not
12 mean that they are required to be here --

13 MR. JENKINS: Okay.

14 THE COURT: -- if he decides not to put them on
15 the stand.

16 MR. JENKINS: All right. What about would I be
17 allowed to present social documents that was out of
18 social media? Mr. Goudelock -- the document that I
19 had knowledge -- or prior knowledge that he was going
20 to make -- matter of fact, those documents are not
21 part of his legal Brief, but he has been allowed to --
22 to --

23 THE COURT: So you're -- when you say social
24 media, things like Facebook and Twitter?

25 MR. JENKINS: Well, I'm talking about people web

1 pages, you know, web pages and different things, or
2 agency web pages, or depositions that's filed with the
3 Workers' Comp Commission and all that's public
4 information.

5 THE COURT: Well, if it's a deposition that's
6 filed with the Commission it's already part of our
7 record, so we already have it.

8 MR. JENKINS: But I also want to -- and then the
9 South Carolina Legislature, I want to deal with Rule
10 42-9-10 which he had on his Form 50 -- Form 51 or
11 whatever.

12 THE COURT: Okay. What's your argument regarding
13 that?

14 MR. JENKINS: Well, based on his -- this states
15 that when a person out of work because of a injury and
16 the Employer has admitted to that injury. Which in
17 this case Amazon -- it did happen -- the injury did
18 happen. Amazon did admit it to the injury, those two
19 are facts. What also is fact is that Amazon because
20 of medical restrictions sent me which is not part of
21 Amazon legal Brief, but it's part of Amazon's
22 employment record, it's part of my employment record.
23 That I was ordered not to come into the plant because
24 they could not accommodate the work restrictions. And
25 during that time period -- during that time period

1 from March -- from February the 21st, 2014 I was just
2 recently terminated as of April 3rd, 2014, but the
3 point that I want to make is that because I was denied
4 access because of work restrictions not able to
5 accommodate by Amazon HR, and that 42-9-10 states that
6 the Employee should receive weekly benefits. During
7 the time of March 5th to July 19th I received short
8 term disability from March 5th up until -- no, I'm
9 sorry. From February the 7th up until March 5th, 2014
10 I received five weeks short term disability payment.
11 So because of 42-9-10 states that weekly benefits
12 should be paid to the Employee -- Employee because
13 he's out. I did not receive any income from March 5th
14 up until July 19th because the Employer kept me out
15 because of my medical symptoms and work restrictions.
16 Therefore, I feel that workers' comp -- that Amazon
17 owes for four and a half months of unpaid benefits.
18 Short term benefits was not paid, eventually long term
19 disability kicked in the middle of July. But for four
20 and a half months, from March 5th up until July 19th
21 there was no income at all. And therefore, Amazon
22 should be held accountable for those benefits.

23 THE COURT: Sir, I hear what you're saying, but
24 I'm also looking at your Form 50 and I don't see where
25 that's a part of your Form 50 and what is before me

1 today.

2 MR. JENKINS: Well, if you take -- if you take
3 January 22nd, 2014 to present that would fall within
4 that category.

5 THE COURT: Correct, but you haven't argued as
6 part of your argument on your Form 50 that you wanted
7 TTD.

8 MR. JENKINS: Well, let's see.

9 THE COURT: And that has to be included as part
10 of your Form 50, otherwise it's not properly before
11 me.

12 MR. JENKINS: Well, you see, due to injury the
13 Claimant requests temporary total disability benefits
14 because of lost compensable time from work and wages
15 to a period of, and I do have from January 22nd, 2014
16 to present. So that would include -- present means
17 now, which income -- some income has been provided,
18 but some -- during some months no income has been
19 provided.

20 THE COURT: Okay.

21 MR. JENKINS: So -- so you take January 22nd, 2014

22 --

23 THE COURT: All right. I see where you're
24 talking about.

25 MR. GOUDELOCK: May I respond, Your Honor?

1 THE COURT: Sure.

2 MR. GOUDELICK: What he cites, 42-9-10 -- 42-9-10
3 says benefits are due when -- for disability.
4 42-1-120 defines disability as a condition because of
5 the injury. Our contention is that the medical
6 evidence before you that he's complaining of that he's
7 been talking about forever, is not going -- not
8 disabling him because of the injury.

9 THE COURT: Okay. And sir, since you have this
10 on your form I will address that in my Order when I
11 issue my Order.

12 MR. JENKINS: Okay. Okay. Thank you. But I
13 would like to get back to making note of some -- some
14 documents that are public regard to -- to address them
15 before the Court if I could.

16 THE COURT: Do you have exhibits that you want to
17 --

18 MR. JENKINS: Yes, sir.

19 THE COURT: That are social media exhibits?

20 MR. JENKINS: Right. Social media exhibits.

21 MR. GOUDELICK: I don't know what they are, Your
22 Honor, but same objection I had at the outset of the
23 hearing. He has not filed a Prehearing Brief and
24 listed any exhibits. He has not offered any APA
25 submission notifications to us timely and I don't know

1 what those are, but I would object to them as coming
2 in.

3 MR. JENKINS: And I want to object to Mr. Rusty's
4 objection because then this -- if the Court agrees if
5 that would be advised, because he has been allowed to
6 present documents that's on social media that I had
7 not received prior to now in his Brief. Those emails,
8 those Twitter Accounts, that was not -- that was not
9 part of his Brief, I had not seen those documents
10 before today. And therefore, I'm already going to
11 assume that this Court has been biased because he's --
12 he's getting -- he's being able to do some things that
13 I can't do.

14 MR. GOUDELOCK: So you're accusing me of making a
15 lie?

16 MR. JENKINS: No, I'm accusing -- I'm accusing
17 Amazon of having a little weight a little bit. Not
18 Mr. -- not Mr. Carroll because I don't want to get
19 Judge Carroll -- I don't want to get on his bad side.

20 MR. GOUDELOCK: What social media things do you
21 have?

22 MR. JENKINS: Well, one, I want to present this
23 document here. I went on Mickle and Bass website and
24 I saw where the former Commissioner, Andrea Roche now
25 works for Mickle and Bass.

1 THE COURT: That's correct.

2 MR. JENKINS: That's correct. But during this
3 very first hearing Ms. Roche, she referred us to
4 Mickle and Bass for mediation.

5 THE COURT: Okay.

6 MR. JENKINS: Which was fine. Derrick Williams
7 was the mediator. During the second attempt that
8 Amazon wanted to mediate he used that same -- which I
9 didn't, you know, you know, I was just trying to
10 accommodate Amazon. He used the same mediator, Mr.
11 Williams. So to me by Ms. Roche being the
12 Commissioner at South Carolina Workers' Comp
13 Commission, by Mr. Derrick Williams being a former
14 Commissioner at South Carolina Workers' Comp and now
15 she works with the same law firm and now also too she
16 referred us to Mickle and Bass. So -- and we even --
17 Amazon used them twice to mediate, so I see -- I would
18 like this document, this social media as some type of
19 bias before -- before the Commissioner. This is --

20 THE COURT: I'll let that come in.

21 MR. JENKINS: Yeah, this -- because you know, I
22 think --.

23 THE COURT: The reason I'm letting it come in is
24 because that's public record, so I'm going to let it
25 come in.

1 MR. JENKINS: Right, public record, right.

2 Public record.

3 MR. GOUDELOCK: We would object, at least to the
4 standpoint of relevancy, Your Honor.

5 THE COURT: So noted.

6 MR. GOUDELOCK: Commissioner Roche, at the time
7 of the first hearing, did not order us to -- to have
8 Mr. Williams mediate the case at Mickle and Bass. I
9 selected and offered Mr. Williams to Mr. Jenkins
10 because he's a former defense lawyer, he's a former
11 Commissioner and he's now a Claimant's lawyer and I
12 thought would be appropriate to handle a case like
13 this. And Mr. Jenkins agreed to that not only that
14 time, but the second time when nobody ordered him to
15 go to Mr. Williams. So if there's bias and he felt
16 Mr. Williams was inappropriate in some manner he
17 didn't have to have it mediated the second time, but
18 it doesn't matter because the mediation failed both
19 times.

20 MR. JENKINS: I would like -- I would like to
21 object to that because when Commissioner Roche made
22 that recommendation, you know, I -- I had no knowledge
23 of Derrick -- Attorney Derrick Williams of Mickle and
24 Bass. So I -- I think this -- I wasn't going to sit
25 in here and argue and say no, I don't know who that

1 is, I don't want that, so I just went along with the
2 Order.

3 THE COURT: But y'all went to mediation and it
4 was both of your decisions to decide that y'all were
5 at an impasse. That's not the mediator.

6 MR. JENKINS: Right. But I'm saying but
7 Commissioner Roche was the one that Ordered us to
8 mediation in the very first hearing.

9 THE COURT: Yes, but she didn't Order you to Mr.
10 Williams or to Mickle and Bass.

11 MR. JENKINS: She did, the very first one she
12 did.

13 THE COURT: We don't pick the mediators. We
14 don't --

15 MR. JENKINS: She -- she did.

16 THE COURT: Well.

17 MR. JENKINS: And all Mr. Goudelock --

18 MR. GOUDELICK: Your Honor, there's nothing in
19 the record --

20 MR. JENKINS: Mr. Goudelock disagreed, but she
21 did.

22 MR. GOUDELICK: I submit to you an officer -- as
23 an office of the Court, I suggested Mr. Williams.

24 THE COURT: Okay.

25 MR. GOUDELICK: She thought it was a good idea,

1 but it isn't in her Order.

2 THE COURT: Okay.

3 (Claimant's Exhibit 1, Mickle & Bass Webpage,
4 marked for identification and entered into the
5 record.)

6 MR. JENKINS: Also, I'd like to present -- I need
7 -- I need this back because I cherish this. What's
8 happened, this is a public document.

9 THE COURT: Okay.

10 MR. JENKINS: It's a advertisement we have in
11 Bamberg. It shows a -- a job fair at Bamberg Job
12 Corps that I was working at Voorhees College at the
13 time and I believe one of my positions at called the
14 Voorhees One Stop helping students, so I'd like to
15 present this to -- it's a public document, if I could.

16 THE COURT: But you said you want it back?

17 MR. JENKINS: Yeah, whenever. Whenever y'all
18 make copies, I mean make a copy of it, but you can
19 keep it for now.

20 THE COURT: Well, I don't want -- if it's
21 something that you want to hold onto as an heirloom, I
22 don't want to take a copy of it. I mean --

23 MR. GOUDELOCK: Once it goes in the record it
24 can't come out.

25 MR. JENKINS: Well, we -- we will make this --

1 you know I present it to the Court.

2 THE COURT: Okay. And I'm sorry, what's your
3 point in presenting it?

4 MR. JENKINS: My point to show me --

5 THE COURT: I guess what's the relevance of it;
6 is what I'm asking?

7 MR. JENKINS: Well, the relevance, it's showing
8 me as far as my capacity at Voorhees College as job as
9 --

10 THE COURT: Okay. We'll note for the record that
11 you presented that.

12 (Claimant's Exhibit Number 2, newspaper article,
13 marked for identification and entered into the
14 record.)

15 MR. JENKINS: Okay. But the reason I would like
16 to go through Dr. Stickler's deposition if I could.

17 THE COURT: Okay. I'm happy to go through it,
18 but here's my point. Anything that has been submitted
19 up to me I'm going to review every bit of it and weigh
20 -- give what I think is the proper weight to the
21 various statements.

22 MR. JENKINS: Yes, sir.

23 THE COURT: But if you want -- since it's in
24 submission you're welcome to refer to it and point out
25 to me what it is you want to point out to me. But in

1 the interest of maybe saving us all some time I am
2 going to review the deposition.

3 MR. JENKINS: Okay. Let's see. Well, one, in
4 the deposition on page five he stated that he saw me
5 on August --

6 THE COURT: Hold on, let me get it in front of
7 me. Okay.

8 MR. JENKINS: I'm on page five, he stated that he
9 saw me on August 28th, 2014. Well, that's incorrect,
10 he actually saw me on August 20th, 2014.

11 THE COURT: Okay.

12 MR. GOUDELOCK: I believe you didn't -- the August
13 20th appointment got cancelled.

14 MR. JENKINS: No, sir.

15 MR. GOUDELOCK: You've already said that earlier.

16 MR. JENKINS: No, sir, August -- we saw him --
17 the very first visit was August the 13th, that was the
18 one we went down there and we spoke to his assistant
19 and she was the one that cancelled it saying that Dr.
20 Stickler had not received the correct information and
21 we were sent back the following week that -- on the
22 20th. Let's see. On page six, down at question 21 --
23 answer 21, when Dr. Stickler answers that he did --
24 did not -- or he did correct -- that he lost
25 consciousness -- he did not have any loss of

1 consciousness, that is not exactly correct. I didn't
2 mention it -- pass out completely, but there is
3 documentation from Amazon where I was sent home
4 because of possibly having one of those episodes of
5 faint -- of passing out because of -- of the high
6 blood pressure.

7 MR. GOUDELOCK: Because of the high blood
8 pressure?

9 MR. JENKINS: Right. High blood pressure and the
10 headaches and -- and weakness.

11 THE COURT: Okay.

12 MR. JENKINS: Okay. If you go down to question
13 21 on page seven where Dr. Stickler answered
14 "intermittent chest pain, in the legs and light -- and
15 previous mentioned lightheaded and syncope -- I hope
16 I'm --

17 MR. GOUDELOCK: Syncope.

18 MR. JENKINS: Syncope, okay, thank you. I don't
19 know what that is. This is -- this is public
20 documentation here it talks about the symptoms of
21 syncope and based on all of my medical symptoms that
22 have been before documented I meet -- I meet a lot of
23 these symptoms here. So this is public record. This
24 -- I got this off -- off the internet.

25 MR. GOUDELOCK: Your Honor, there -- there --

1 there is nothing that -- you can get anything off of
2 the internet. It's different than a public record.
3 Medical evidence has got to have validity to support
4 it and there's nothing that authenticates the validity
5 of that other than a Google (inaudible).

6 MR. JENKINS: Then that goes to social media far
7 as my Twitter Account and Facebook.

8 MR. GOUDELOCK: That's not so, Your Honor.

9 MR. JENKINS: You just said you can get anything
10 off the internet. In that case that applies to
11 everything. Some people have --

12 THE COURT: I'm sorry. Tell me where that came
13 from again.

14 MR. JENKINS: It came off the web -- web, I got
15 it off the internet, off social media.

16 MR. GOUDELOCK: He Googled symptoms for syncope.

17 THE COURT: Okay.

18 MR. JENKINS: No, I -- I really -- really, to be
19 honest with you I only came across it yesterday when I
20 was going back over Dr. Stickler's deposition. I
21 printed it out today.

22 THE COURT: Okay. I'll allow it to come in if
23 it's just referring to what syncope is, that's fine.

24 (Claimant's Exhibit Number 3, definition of
25 syncope, marked for identification and entered into

1 the record.)

2 MR. JENKINS: Right. But here today --

3 MR. GOUDELOCK: Your Honor, if you'd just note
4 our objection. There's no mathematical basis --

5 MR. JENKINS: Right. But -- thank you. But it's
6 basically --

7 MR. GOUDELOCK: -- of authenticity for it to come
8 in as any type of expert opinion.

9 MR. JENKINS: But if Dr. -- Dr. Stickler made
10 mention of it. He was -- he was the one that Amazon
11 depended on to give them a second evaluation. He made
12 mention of it in his deposition so I think therefore
13 by him referring to it --

14 MR. GOUDELOCK: Do you understand my point, Your
15 Honor?

16 MR. JENKINS: That -- that --

17 THE COURT: Yes, I do.

18 MR. JENKINS: -- but that should be allowed.

19 THE COURT: Okay.

20 MR. JENKINS: On page nine go down to question
21 12. And Ata -- and Dr. Stickler answered -- you got
22 to have two exams from Dr. Ata on June 20, 2014 and
23 one for August 26, 2013. Well, the Amazon legal Brief
24 it does not have the June 20th, 2014 medical
25 documentation from Dr. Ata in their legal Brief. But

1 here Dr. Stickler confirmed here that he had a exam
2 from Dr. Ata that Amazon had submit to him on June 20,
3 2014. But that's not in their legal Brief.

4 THE COURT: Okay. And that's noted, and here
5 again, keep in mind they have the right to submit what
6 they --

7 MR. JENKINS: Right. Right.

8 THE COURT: -- want to submit and what they don't
9 want to submit.

10 MR. JENKINS: Right. But I got a right to
11 distort any type of mistruth that they --

12 THE COURT: Yeah, you can pull up, but just
13 understand if it's not in their legal Brief they're
14 still within their right.

15 MR. JENKINS: Yes, sir. Let's see. If you go to
16 page ten and question 13 and 19, here's where Dr.
17 Stickler who Amazon referred on a second opinion, now
18 giving a history, Dr. Ata who is approved neurologist,
19 he did not make this determination. This is in
20 addition -- Dr. Stickler made an additional
21 notification of a symptom in my left foot and that's
22 from 13 the question to number 19 on page ten. He
23 said, "I did find a mild what you call hyperthetic
24 sensation. Meaning hypersensitivity in the left foot
25 on both the top and bottom of the foot."

1 MR. GOUDELOCK: What does he say on 23?

2 MR. JENKINS: We'll get to that. We'll get to
3 that. On 23?

4 MR. GOUDELOCK: Says he doesn't expect foot
5 numbness to be part of your mild head injury.

6 MR. JENKINS: Well, that -- that -- that -- but
7 when we dealing with that, we dealing with -- but he
8 did -- he did say he found it now. If you go to page
9 12 and you take question 23 -- well, number 23 all the
10 way to number seven on page 13 and I really want to
11 focus on page 13 at the top. He said he was able to
12 go and get (inaudible) onsite medical without any
13 clear documentation of a concussive event. And you
14 were willing to continue work at the time. That is a
15 distortion because as I stated earlier on February the
16 14th, I believe, Amazon insisted that I get medical
17 treatment by their provider Health Point and so
18 because I was in so much distress on the day that I
19 came in to work. So that is not -- that is not
20 correct. And let's go to page 11, please. It's down
21 in -- go to number 12 when he talks about condition in
22 his right leg weakness and near syncope or whatever
23 you call it, episode, and the chest pain which did not
24 occur based on my history and reviewing the records
25 concerning my (inaudible) in February. That is

1 another distortion because when I went to Health
2 Works, Amazon workers' comp provider, there is
3 documentation that states of leg weakness, feeling
4 very tired and exhausted. So that -- that's another
5 distortion which is not true. Let's go to page 15.
6 As I stated before, if you look at Dr. Stickler's
7 medical report that he provided he stated, "After
8 possibly suffering from migraine headaches could
9 increase the dose -- medicine dosage and also may be
10 possible to be put on light restrictions in order to
11 determine my capabilities." Well, you see here on the
12 deposition from question eight to 15 how he changed
13 his story and said, "So the physical restriction that
14 you imposed on him at this time is not because of his
15 work injury?" "It was because of subjective symptoms
16 at that time." Well, in his initial evaluation he
17 made the determination that based on the work injury I
18 could be suffering from migraine headaches and
19 therefore being the hypersensitivity in my foot
20 therefore he felt that work restrictions would
21 probably be the best thing at the time. So therefore
22 this is another distortion that Amazon, you know, got
23 him to do.

24 MR. GOUDELOCK: The records will speak for
25 themselves, Your Honor.

1 THE COURT: That's the point I was getting ready
2 to make, Mr. Jenkins, is understand I will let the
3 medical evidence speak for itself --

4 MR. JENKINS: Yes, sir.

5 THE COURT: -- and we'll certainly note any
6 contradictions.

7 MR. JENKINS: Yes, sir. But let's make the --
8 but it's hard to do that when you don't have the
9 complete story.

10 THE COURT: Well, I have his records which you're
11 pointing out.

12 MR. JENKINS: Yeah. Well, let's go to page 17
13 over here and then go down to question -- let's start
14 with question eight, number eight where he ask "Is
15 there anything that you saw in the evaluation that the
16 Claimant needs to see a psychiatrist because of his
17 work injury?" And Dr. Stickler stated, "No, but I
18 don't think that I completed a complete psychiatric
19 evaluation at the time." But those issues did not
20 come up in the course of the evaluation, so here in
21 this thing right here, Amazon is basing their medical
22 rating and their determination, based on Dr.
23 Stickler's evaluation. But Dr. Stickler stated in his
24 own deposition that he did not complete a full
25 evaluation. So therefore there's another distortion.

1 Let's see. I want to go a little further. Look on
2 page 18 starting at question one, go down -- number
3 one going to seven. "Any indicated need for him to
4 see a spine surgeon for his neck or leg because of his
5 work injury?" "Well, it was identified that he had a
6 degree of impairment within the cervical spine, but
7 the symptom related -- related to me at that time was
8 not indicative of a cervical spine impairment. That
9 was not recommended." Well, this is another
10 distortion because Dr. Ata record based on the MRI
11 that suggested this and because you don't have a
12 complete picture of the medical documentation Dr. Ata
13 was the one that referred me to a cervical spine.

14 MR. GOUDELOCK: The question he was asked, Your
15 Honor, was whether he needed to see a cervical spine
16 surgeon because of his injury.

17 THE COURT: So noted.

18 MR. JENKINS: They said that was not recommended
19 to him, but based on Dr. Ata report, the approved
20 neurologist by Amazon, indicated such in his medical
21 documentation. That's fact. And you go down to
22 number 15 through 20 on the same page.

23 THE COURT: We're still on 18?

24 MR. JENKINS: Yes, sir.

25 THE COURT: Okay.

1 MR. JENKINS: When he talks about the nerve
2 conduction study and the EMG he's had, it looks like
3 any type of radicular pathology -- no, I believe
4 there's no deduction -- it says in both lower
5 extremity and did not find evidence of neuropathy or
6 lumbar. But it did not evaluate the potential -- the
7 potential for cervical -- I can't pronounce that.

8 MR. GOUDELOCK: Radiculopathy.

9 MR. JENKINS: Radiculopathy. Thank you. So here
10 again, this is what they have based their
11 determination on, evaluations, but here again, Dr.
12 Stickler has not confirmed a completed evaluation
13 based on the medical documentation of the MRI. And
14 also based on what the other doctors, Dr. Muhammed has
15 stated. Going down -- let's see what else I got here.
16 And here, this is public record, these two. These are
17 two depositions; one, -- well, they are two potential
18 scheduled depositions. This is the one where Amazon
19 notified Dr. Muhammed who was approved neurologist of
20 a possible deposition that would take place on Monday,
21 the 10th day of November, 2014 at 2:30 p.m. That has
22 not has happened yet. But, and this is the one with
23 Dr. Stickler, where it stated the deposition with him
24 on the date of the 14th of January, 2015 at 2:30 p.m.
25 This one happened because Amazon wanted him to say

1 with specific type of language, but Dr. Stickler --
2 Dr. Muhammed is the one that feels that more treatment
3 is needed based on his medical determination and my
4 medical symptoms and would not provide Amazon with a
5 medical rating. This is why this deposition has not
6 happened. These are both public documentations and so
7 -- and because -- and because he has stated -- he has
8 stated that he would not give a medical rating until
9 he received additional evaluations --

10 MR. GOUDELOCK: The objection I made earlier,
11 Your Honor, about hearsay. He can't testify to what
12 somebody said unless he can offer proof.

13 MR. JENKINS: But we can submit it as his
14 deposition was properly scheduled.

15 THE COURT: Mr. Goudelock, do you --

16 MR. GOUDELOCK: No objection.

17 THE COURT: Okay. Thank you.

18 MR. JENKINS: So we just can submit that Amazon
19 was --

20 MR. GOUDELOCK: Claimant's one and two?

21 THE COURT REPORTER: Three and four.

22 MR. JENKINS: -- was planning on seeking a
23 deposition with Dr. Muhammed, when it never happened
24 --

25 THE COURT: I'm sorry, he's -- I just want to

1 make this clear for me. I'll let you continue your
2 thought in one second.

3 (Claimant's Exhibit Number Three, notice of
4 Deposition of Dr. Ata, marked for identification and
5 entered into the record.)

6 (Claimant's Exhibit Number Four, notice of
7 Deposition of Dr. Stickler, marked for identification
8 and entered into the record.)

9 MR. GOUDELOCK: I'm sorry.

10 THE COURT: Okay, Mr. Jenkins, you can continue.

11 MR. JENKINS: Okay. Thank you. The next
12 document that I would like to submit -- when we're
13 talking about social media we're talking about public
14 documents, right? Even though he's not a expert
15 medical con -- personnel, but this is in there where
16 retired, Kevin Colby, had concussive symptoms very
17 similar from every day. This is -- this is -- gave
18 you a supportive document. He's not a medical expert,
19 but this is social media and to be safe --

20 THE COURT: I'm not going to let that in.

21 MR. GOUDELOCK: Your Honor, --

22 THE COURT: I'm sorry. I gave you some latitude
23 on this one, but I'm not going to give you latitude on
24 that one. Okay? I just can't let that in.

25 MR. JENKINS: Okay. Well, on this other one this

1 is another social media documentation, but this is by
2 the South Carolina Brain Injury Leadership Council.
3 This is expert testimony from doctors who work in the
4 field who are a part of this Brain Leadership Council
5 that talks about traumatic brain injury, the effects
6 of it, (inaudible) that you need and that each one
7 varies depending on the person age and all that.

8 THE COURT: Okay. And sir, I already have -- I
9 have volumes of information like that, so I don't need
10 it for a determination of the case.

11 MR. JENKINS: Yeah, but I still would like to
12 submit just as for the record, if I could.

13 THE COURT: Well, I --

14 MR. JENKINS: If I could.

15 THE COURT: Mr. Goudelock, do you object to this
16 coming in?

17 MR. GOUDELOCK: I do object to it coming in, Your
18 Honor.

19 THE COURT: Okay. Sir, I'm not going to let that
20 in.

21 MR. JENKINS: Okay.

22 THE COURT: But as far as it affecting a
23 determination of the case I'm aware of information
24 like that, so --

25 MR. JENKINS: I understand, but the only reason

1 why I wanted to have it for the record because just in
2 case you know, we haven't -- I have to proceed to the
3 Court of Appeals it's better off to have those records
4 because see they going to say well you did not have
5 your record during the previous hearing. Another
6 further documentation that I would like to submit. I
7 had it -- during the original hearing Amazon spent so
8 much time having unauthorized visits disputed before
9 Commissioner Roche. Commissioner Roche during her
10 Finding agreed with Amazon. And I come to present to
11 the Court then as of January 20, 2015 Amazon issued
12 subpoenas for all those visits of unauthorized medical
13 care that I was not allowed to get mileage on to that
14 part of the record. So my -- my argument is the
15 workers' compensation already agrees with Amazon then
16 why would Amazon as of January 20th, 2015 issue
17 subpoenas for all those unauthorized medical visits?
18 Such -- such as to the very ones that I'm not being
19 allowed to submit here today such as The Family Health
20 Center.

21 THE COURT: But sir, you're not being allowed to
22 submit those here today --

23 MR. JENKINS: Right. Right.

24 THE COURT: -- because you didn't properly submit
25 them.

1 MR. JENKINS: Right, right, right, right, but the
2 point -- the whole thing about that though, but Amazon
3 be able to subpoena the records. Amazon, even though
4 they were not part of Amazon legal Brief, Amazon have
5 a public document where they issue subpoenas for all
6 those medical records including Richland Medical
7 Center, Dr. Muhammed, Norfield Medical Center, Dr.
8 Eden, but yet, Dr. Tomarchio, Dr. Gonzalez, but yet,
9 you know, I'm not able to present all their records
10 when Amazon is the one that issued subpoenas for the
11 records though.

12 THE COURT: And you could have if you had
13 properly listed stuff.

14 MR. JENKINS: Right. Right, but you -- I
15 understand, sir, but even though -- even though I may
16 have not properly listed them, they saw those things
17 --

18 THE COURT: And here -- be also aware of this, if
19 there were subpoenas that were issued the Commission
20 is aware of that. That's all a part of the record.
21 We have all of that information.

22 MR. JENKINS: Right. So then does the Commission
23 have to ask where are the records then? Why didn't
24 Amazon submit the records? You know why Amazon didn't
25 submit the records; because the records dispute their

1 claim that a injury is not as serious as -- as it has
2 been and that's why they have not submitted the
3 records. But the subpoenas -- they got the records.
4 And so by Amazon saying that --

5 MR. GOUDELOCK: Your Honor, this has been ruled
6 on and --

7 MR. JENKINS: Right. Right. But let me -- let
8 me finish though.

9 MR. GOUDELOCK: -- and determined over and over
10 again.

11 MR. JENKINS: Right. But let me finish though.

12 MR. GOUDELOCK: I'm happy for him to go on and on
13 with the --

14 MR. JENKINS: No, I'm not happy either, I'm a
15 little under the weather; I'm sick. But I want to
16 make my argument. By Amazon saying they're not aware
17 of these documents --

18 MR. GOUDELOCK: Nobody said we weren't aware.

19 MR. JENKINS: These subpoenas verify -- they
20 verify that Amazon got those records, therefore, I
21 should be allowed -- the reason I didn't follow the
22 proper procedure, I wanted to follow what I was told
23 by the Workers' Comp Commission staff. Amazon had
24 prior knowledge because there's no way possible that
25 if you issue subpoenas those medical providers are not

1 going to provide you all the records that they have on
2 that client, that patient if you subpoena those
3 records. So Amazon had prior knowledge, so I'd like
4 to submit these records to the Court. Even though you
5 have them but I still would like to submit them
6 because I'm afraid this is going to have to go to the
7 Court of Appeals, so I want all these things in there.

8 THE COURT: You've already -- let me explain
9 something to you.

10 MR. JENKINS: Yes, sir.

25 have it.

1 THE COURT: That's his deposition?

2 MR. JENKINS: Yes, sir.

3 THE COURT: No, I have his full deposition.

4 MR. JENKINS: Okay. Okay.

5 THE COURT: Mr. Goudelock?

6 MR. GOUDELOCK: Your Honor, for the sake of not
7 cluttering the record, I'm going to object to it. He
8 hasn't listed any of this stuff, there are pages and
9 pages of them. If you let them in that's fine, but --

10 MR. JENKINS: They're your documents.

11 MR. GOUDELOCK: I know. I've already told you we
12 subpoenaed them. We're aware of the records and we've
13 subpoenaed them. I'm not disagreeing with you. I'm
14 just trying --

15 THE COURT: And I'll let them in just because
16 they're part of the record, but Mr. Goudelock has --
17 like I say, I'm giving you a lot of latitude here.

18 MR. JENKINS: Yes, sir, and I appreciate it.

19 THE COURT REPORTER: Am I going to mark these?

20 MR. GOUDELOCK: Mark them as a group.

21 (Claimant's Exhibit Number 5, subpoenas and
22 various documents, marked for identification and
23 entered into the record.)

24 MR. JENKINS: That -- that's it for me, Your
25 Honor. Thank you, sir.

1 THE COURT: Thank you. Mr. Goudelock, anything
2 more?

3 MR. GOUDELOCK: Nothing further, Your Honor.

4 THE COURT: All right. That being said, that
5 concludes this proceeding.
