
**NOTICE OF APPEAL**





Enclosed for filing is a notice of appeal in the above case. Also enclosed are the following:

- (1) Proof of service of the notice of appeal on the respondent[s].
- (2) A copy of the order[s] [judgment] which is [are] to be challenged on appeal.
- (3) A filing fee of \$100.
- (4) This appeal is being filed with the South Carolina Court of Appeals because, upon information and belief, Appellate asserts:
  - a. The Proposed Order submitted by the Respondent's attorney was Improper, and was not signed by the Honorable Judge before the Final Order was submitted to the Clerk of Court (enclosed).
  - b. Trial Court Lacks Subject Matter Jurisdiction to hear and decide the case.
  - c. The Merits of the case were never heard before the Trial Court.
  - d. Trial Judge erred in dismissing the case With Prejudice without deciding the case on the Merits.
  - e. Appellant's prior Motions that were duly filed and recorded by the Trial Court were never heard.
  - f. Trial Court erred in requiring an attorney appear for Pro Se Plaintiffs in the instant matter.
