
Appellants/Respondents hereby move pursuant to Rule 263(b), SCACR, for a 30-day extension of the time in which to serve and file Appellants/Respondents' Initial Appellants' Brief and Designation of Matter to be Included in the Record on Appeal in this case. The grounds for this motion are that there is good cause to grant the requested extension, as the following shows:

1. Appellants/Respondents commenced this appeal by serving a notice of appeal on March 8, 2018, and their counsel contacted the court reporter seeking the only remaining needed transcript on the same day.
2. Counsel for Appellants/Respondents received that transcript from the court reporter on the next day, March 9, 2018.
3. On March 13, 2018, Respondent/Appellant served a notice of cross-appeal.
4. On March 15, 2018, the clerk of this court mailed counsel a letter stating that "[t]he times for perfecting this appeal will run from the service of the last notice of appeal."
5. The deadline for service and filing of Appellants/Respondents' Initial Appellants' Brief and Designation of Matter to be Included in the Record on Appeal thus appears to be April 12, 2018.
6. This is the first extension that Appellants/Respondents have sought in this appeal.
7. Respondent/Appellant's counsel has consented an extension of this deadline.

8. The undersigned counsel has recently made an unexpected out-of-state trip to visit a sick family member, and he also has a trial coming up on April 19. These events, coupled with the press of counsel's case load and schedule of motions hearings and writing deadlines, has delayed work on the brief.
9. Appellants/Respondents' counsel believes there is good cause to grant the requested 30-day extension to May 14, 2018.

WHEREFORE Appellants/Respondents pray for an order extending the time in which to serve and file their Initial Appellants' Brief and Designation of Matter to be Included in the Record on Appeal to May 14, 2018.


