
NOTICE OF APPEAL

Francisco Cedano Ramirez appeals the decision of the of the Full Workers Compensation Commission dated March 30, 2018, which Appellant received a copy of on March 30, 2018. The issues on appeal are:

1. Whether the Full Commission erred in finding that under S.C. Code Ann. § 42-1-130 Claimant was a sole proprietor who was not included under Cedano Roofing's workers' compensation policy;
2. Whether the Commission erred in finding that under S.C. Code Ann. § 42-1-130 Claimant is not an employee of May River Roofing or Cedano Roofing; instead, he is the sole proprietor of Cedano Roofing; and
3. Whether the Commission erred in finding that under S.C. Code Ann. § 42-1-400 to -450 Claimant cannot recover as a "statutory employee" of May River Roofing or Cedano Roofing.





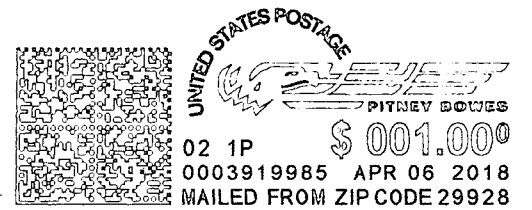
