

Defendant Paul Lavar Harris appeals his conviction and sentence in this case. The defendant pled guilty on March 26, 2018 on one (1) count of trafficking cocaine 28 g or more, one (1) count of trafficking cocaine 10 g or more, one (1) count of trafficking crack cocaine 10 g or more but less than 28 g, and one (1) count of trafficking crack cocaine 10g or more but less than 28g- 2nd offense. He was sentenced to four (4) terms of fifteen (15) years to be served concurrently. This appeal is taken from the sentencing sheets as filed in Spartanburg County.
