

Pursuant to Rule 222, SCACR, Respondent Tony Megna hereby moves the Court for an order taxing Appellant James Anasti with the costs incurred by Respondent in the present appeal. Following a circuit court order denying Appellant's motion for sanctions against Respondent Megna under Rule 11, SCRCP, Appellant appealed the ruling to this Court arguing Respondent Megna asserted frivolous and disingenuous defenses in the underlying state court action in violation of Rule 11. 


