This Court has received your petition for a writ of certiorari and appendix to review the decision of the South Carolina Court of Appeals in this case. This case has been assigned the appellate case number that appears above. Please use this number on all future correspondence relating to this matter.

All parties to this matter are advised that all filings must comply with the requirements of Rule 267 of the South Carolina Appellate Court Rules (SCACR). The SCACR are available online at www.sccourts.org/courtreg. Additionally, any filings submitted by counsel admitted in South Carolina must include counsel's bar number.

The attention of the parties is directed to the order relating to the inclusion of personal data identifiers and other sensitive information in documents filed with the Supreme Court of South Carolina and the South Carolina Court of Appeals.

note that the responsibility for insuring that information is redacted or sealed as required by this order rests with counsel and the parties. This office will not review filings for redaction or to determine if materials should be sealed.

For this matter to proceed, the following deficiencies will need to be corrected within ten (10) days of the date of this letter:

- (1) Since Louis S. Moore, Esquire, was counsel of record before the Court of Appeals, he remains counsel of record before this Court. Rule 264(a), SCACR. Therefore, the petition for a writ of certiorari and appendix will need to be amended to reflect that he is counsel in this matter.
- (2) As the South Carolina counsel associated for the purpose of your *pro hac vice* admission, Mr. Moore will need to sign the petition for a writ of certiorari. Rule 404(i), SCACR ("The South Carolina attorney of record shall at all times be prepared to go forward with the case; sign all papers subsequently filed; and attend all subsequent proceedings in the matter, unless the tribunal specifically excuses the South Carolina attorney of record from attendance." [emphasis added]).
- (3) You have not submitted the certification of counsel required by Rule 242(d)(1), SCACR. This certification will also need to be signed by Mr. Moore.
- (4) The caption on the petition and appendix are incorrect and will need to be corrected. The caption should be:

Nichols, **Petitioner**,



- (5) Earlier, this office raised concerns that the record on appeal included as part of your appendix was not identical to the record on appeal submitted to the Court of Appeals, and you have submitted a record on appeal that appears to be the same as that filed with the Court of

Appeals. However, the copy you have provided is missing various pages. This will need to be corrected.
