I Jana' Randolph am writing you this letter to explain to you the following events that began on April 8, 2014 as well as the events that took place afterwards that lead to my plea for justice.

On April 8, 2014 I went shopping at Wal-Mart located at 1326 Bush River Rd Columbia SC 29210. I was with a Wal-Mart sales associate who was helping me find some smoked turkey wings. He took me the area where the item was supposed to be located. While continuing to shop I began to slip and slide on an unknown substance on the floor. I grabbed the freezer case to try and break my fall unfortunately I fell to the ground. I thought I could get up but the substance around me was too slippery, and I was not able to get up. I began to feel a burning sensation and sharp pains in my right hand, right arm, and right shoulder. An associate walked past me, I asked for help he informed me he was on break and kept walking past me. I was asking for help, trying to get up my back was hurting so bad I was having spasms bad by this time the manager Mike came to assist me offering to help me up. It was obvious I couldn't get up I was in the worst physical pain my legs were numb. I was wet from the substance and from me urinating after the fall. Mike the manger did the report while I was still on the floor. letting me know it was their fault, and apologizing to me. He began attempting to help me up again but I couldn't move my body was inflamed with shooting pains. I called the ambulance on my phone after I realized they weren't trying to contact medical services. When ems arrived they took me the emergency room. This incident lead to long term treatments and loss of my independence in multiple ways. I'm now severely incontinent as I am unaware when I am urinating. I had to lay through doctors poking and prying at my vagina, running test to see why I can't feel my lady area. I wear pads or adult under garments since I don't know if I have to urinate. I was seeing a specialist for nerve damage getting injections in both feet and under arm until my insurance was no longer accept at the practice. It will cost me 125,000 every three years. I have permanent nerve damage in my right arm and leg and both of my feet and my back damage to the bones in my neck and hips to include muscle deficiency to my right leg due to the fall on 4/8/14.

I initially met my attorney Mr. Hope E. Garner through the legal aid referral hotline, we had an initial consultation in April of 2014. Mr. Garner advised me that we did have a case and agreed to represent me in my suit against Wal-Mart. Later on we had our second meeting he asked me additional questions such as if I believed in black magic I told him I don't know what that is, He went on to explain it was like voodoo and I explained what I heard of it he laughed, he asked me did I call Rev. Al Sharpton or Jessie Jackson I replied no! He said "good I don't want a circus"

in my deposition. - I agreed. Mr. Garner, Wal-Mart attorney- Michael Montgomery and I met and conversed about the case. Mr. Montgomery apologized to me for the incident that caused my injuries and also said that he could see that I was in pain and would try and resolve this case as quickly as possible. The deposition was set up fast for 01/21/2015. The Mediation was set up quickly my attorney confirmed Mr. Montgomery gave his introduction also informed me they will "expedite my payment" in his own words. My attorney Mr. Garner, another Wal-Mart attorney, Mr. Montgomery, the mediator (Pamela Roberts), and myself were present. The Wal-Mart attorney asked what were we asking for? Mr. Garner had no strategy or strategic response.

I asked Wal-Mart's Attorney could Mr. Garner and I speak privately for a moment. Wal-Mart agreed they exited out the door. Mr. Garner told me to let him do the talking and take what they offer. I immediately called my specialist on speaker phone while me and my attorney Mr. Garner was strategizing I asked how much were my shots to treat my nerve damage upper and lower she said around 125,000 every three years. I said I can't afford that but I need the treatment it helped me a lot but the side affects affected me my toe nails turned Brown and elevated my

blood pressure which was already high from pain. I never had blood pressure problems before this incident, Due to the extremely high cost of the treatments and the Southeast Neuropathy Medical Center no longer accepting my insurance at the time I had to stop going because I couldn't afford it. I told my attorney we need to start at \$ 200,000 including them covering medical long term as all of my doctors have agreed that as I get older it will get worse.

Mr. Garner simply said "excuse me" and stepped out of the room. I looked out the door and saw all of them talking, when he came back in I asked my attorney what they were speaking of he said "I wasn't talking to them" when I saw it with my own eyes. The attorney's came back into the room the mediator spoke and we began to continue the mediation. Mr. Garner started talking. I interjected and asked for \$300,000 and explained what I and my attorney learned together of cost of the treatments from one of my doctor's. I asked for long term medical Wal-Mart denied the long term medical. Mr. Montgomery said he can work with and around 300,000 Mr. Garner interrupted with verbal aggression saying "I can't and won't represent you

in Lexington country" " what would you do with that kind of money." in front of everyone I asked him to explain why he won't represent me in Lexington he replied " because there are a lot of reserved whites in Lexington" and I said what does that mean he said "their are reserved Jews" I said what they got to do with it. he got quiet, I asked is it because of the Nazis? he nodded informing me of other reserved parties in Lexington I said is it because I'm black he nodded yes. Mr. Montgomery immediately interrupted Mr. Garner addressing his behavior. Mr. Montgomery advised him that he was violating so many laws including my color of rights law as well as my civil rights and many other laws and that he was incriminating himself as an officer of the court.

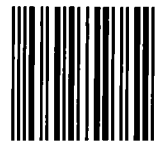
He went on to tell him he should not be in practice at all! Mr. Montgomery told me if I drop my lawsuit

against them he will represent me in suing my attorney Mr. Garner and get me my disability. I was in dismay, disbelief, and embarrassed, Mr. Garner made the statement " if you go to trial, I will not represent you " he said this about several times during the mediation to the point that Wal-Mart withdrew the offer. I stated I would get another attorney Mr. Garner told me he has colleagues throughout sc. By this time I was dismayed, crushed, and hopeless in a desperate cry for justice, I asked Wal-Mart what were they was going to do? Mr Montgomery said he will give me 500 dollars.
