

Respondent SCBT, N.A., hereby moves the Court for an order amending the caption to change the name of Respondent from "SCBT, N.A." to "South State Bank." After the filing of this action in the lower court, SCBT, N.A., converted from a federally-chartered banking association to a South Carolina state-chartered banking corporation known as SCBT. SCBT subsequently filed Articles of Amendment to its Articles of Incorporation with the South Carolina Secretary of State on May 7, 2014, changing its name to South State Bank effective June 30, 2014. 
