
RESPONDENT’S MOTION TO SUPPLEMENT THE RECORD

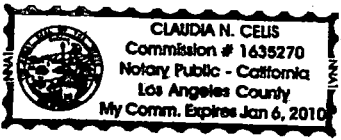




