

CALCULATING OF SENTENCE RELATED EARNED WORK CREDITS. THE PASSAGE OF THE JUNE 3, 1986 OMBIOUS CRIMINAL JUSTICE IMPROVEMENT ACT 13, HAS AND STILL BEING APPLIED TO ME IN AN ERRONEOUSLY, CAPRICIOUSLY MANNER. SECTION B DOES NOT STATE VIOLENT CRIME ARE NOT ELIGIBLE. FURTHERMORE PAROLE ELIGIBILITY DATES MAY BE REDUCED BY EARNED WORK CREDITS FOR ALL SENTENCES EXCEPT FOR MURDER. BUT AT THIS TIME EARN WORK CREDITS DOES NOT SHOW UP IN THE DATE SCREEN UNDER MY CRITERIA. BY AND THROUGH THE DIV. OF CLASSIFICATION INMATE RECORDS OF THE SOUTH CAROLINA DEPARTMENT OF CORRECTIONS. I'M INCLUDING ENCLOSED DOCUMENTARY EVIDENCE AND REQUEST FOR ASSIGNMENT OF CLASSIFICATION RECORDS. WHEREBY S.C.D.C POLICY OF 2607, EARNED WORK CREDITS HAVE BEEN DENIED AND THE CRITERIA DENING PATRICK STROZIER 1-26-16 DUE PROCESS TO GRIEVANT UPON VIOLATIONS REQUEST BACK DATE CREDITS & HERRING, AND TO KNOW MY CRITERIA.

RESPONSIBLE OFFICIAL'S DECISION AND REASON:

Your concern has been reviewed. You stated in this grievance that the SCDC is erroneously calculating your sentence related Earned Work Credits (EWC). A review of your EWC History Assignment reveals that on October 30, 2015, you were assigned an EWC Level 3 for 5, as a Wardkeeper Assistant. You are receiving the appropriate amount of EWCs.

Therefore, your grievance is denied.
