
Dear Mr. Brock:

I hereby acknowledge receipt of your request for transcript dated March 4, 2018 in the above-captioned case held in front of Nicholson on September 20, 2017. Please note that the address on the envelope was incorrectly written as P.O. Box 824 instead of the correct P.O. box number, so there was a delay in my receiving this. I have reviewed my records and estimate that your transcript will be 35 pages. Based on the current rate of \$3.25 per page, the cost will be \$107.20, which includes Keyword Indexing and postage.
