That on or about OCTOBER 26, 2015 while at T DR in the OLYMPIA Mag Dist of Richland County it is believed that one JONATHON CAMPBELL did commit the crime of CRIMINAL SEXUAL CONDUCT - 3RD DEG in that he did while the victim was sleeping at the incident location remove the victim's clothing & vaginally penetrate the victim with his penis. The victim was asleep when the assault first took place & woke up while the subject was penetrating her vagina with his penis. When the victim woke up the victim she observed the subject laying over her with his penis inside of her. When the victim woke up the subject immediately got off of her & the victim ran from the location. The victim ran to a safe location & called 911 & was transported to RMER for treatment to the injuries that she sustained while attempting to flee from the subject.
