
**CONSENT MOTION FOR LEAVE TO ALLOW RESPONDENTS TO FILE AN  
AMENDED DESIGNATION OF MATTER AND FOR AN EXTENSION OF TIME  
FOR APPELLANT TO FILE THE RECORD ON APPEAL**

Respondents hereby seek leave of the Court to file an Amended Designation of Matter to be Included in the Record on Appeal. Respondents filed their initial Designation in this matter on May 22, 2017, and the Record on Appeal, which is in the process of being compiled but which has not yet been finalized, is due to be filed on or before August 1, 2017. Respondents seek to include in their Amended Designation of Matter a limited number of additional pages from the Trial Transcript that were referenced and discussed in Respondents' Initial Brief, but inadvertently not included in the initial Designation of Matter. Respondents' Amended Designation of Matter, which they would propose to file in this case, is attached hereto as Exhibit 1.

Counsel for Appellant has consented to this Motion for Respondents to file an Amended Designation of Matter as reflected in the attached e-mail (Exhibit 2). In addition, the parties would jointly request, by consent, a 3-day extension of time for Appellant to file the Record on Appeal. A 3-day extension would ensure that the Record on Appeal can be timely compiled, with sufficient copies prepared for the parties and the Court, once the Court has the opportunity to address this motion. With a 3-day extension of time, the new deadline for filing of the Record on Appeal will be August 4, 2017.

Based on the foregoing, Respondents, with the Consent of Appellant, respectfully request the Court grant the relief sought in this motion to allow Respondents to file an Amended Designation of Matter and allow Appellant to file the Record on Appeal on or before August 4, 2017.




