I hereby object to the respondent's Motion to Dismiss due to the fact that the respondent is trying to mislead the court by putting their twist on the facts.


1 In the Motion to Dismiss the respondent stated that DLJ Mortgage was given the Summary Judgment when in fact it was GMAC mortgage.


