
Pursuant to Rule 222, SCACR, Respondents Bessie Huckabee, Kay Passailaigue, and

Attorney Fee of W. Westbrook Wills III \$2,500

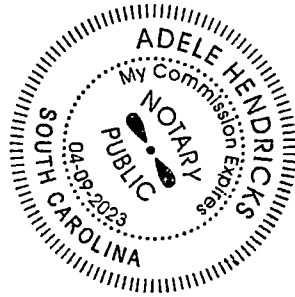


