


**PETITION TO RELAX RULE 243(h)



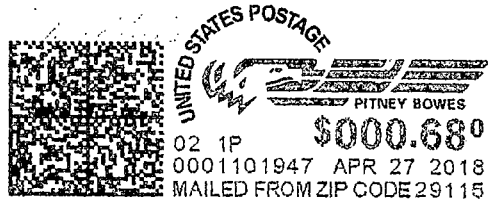
