




Dear Clerk:

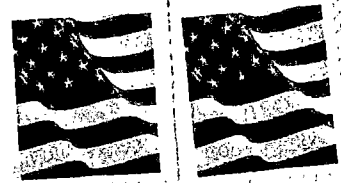

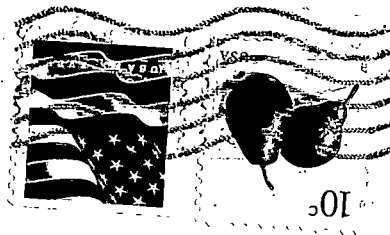
