ORDER

Respondents' motion to strike is granted. Appellant's record on appeal shall not include any matters not designated by either party. Furthermore, the record on appeal must include all matters designated by both parties. Within twenty days of the date of this order, Appellant must serve an amended record on appeal that omits all matters listed in the motion to strike that are not properly included in the record on appeal. Furthermore, Appellant must include in the amended record on appeal all items designated by Respondent, including the items listed in the motion to strike. Appellant shall provide this court with four copies of the amended record on appeal. The request to dismiss this appeal is denied.
