

By copy of this letter I am herewith serving a copy of the enclosed on all attorneys of record and the lower administrative tribunal.

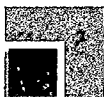


