Appellant respectfully request that the Court allow him to Order the Transcript Out of Time. To support this Motion Appellant will show the following:


1. This Appeal arises from a post-trial motion that had two separate hearings.





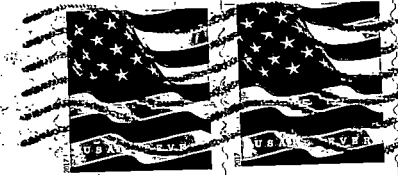
