
On January 10, 2018, the above referenced trial was heard before the Honorable Charles



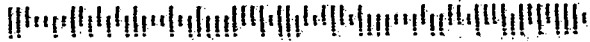

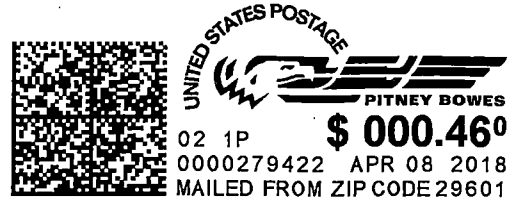
