

WHEREFORE, the undersigned counsel would respectfully request a thirty-day extension, until **June 4, 2018**, in which to file the initial brief of appellant and designation of


matter in this case based upon the above exigent circumstances. Counsel requests that time limits for filing the brief be held in abeyance pending a ruling on this motion.


