

DESCRIPTION OF OFFENSE: Larceny / Grand Larceny, value more than \$2,000 but less than \$10,000

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about July 9, 2016, while within the City of North Myrtle Beach, the Victim drove the Defendant and co-Defendant southbound on Hwy 17 through the City in her white 2012 Chevy Malibu valued at approximately \$7,500.00. At approximately 11:15 am, the defendants shot the Victim in the head with malice aforethought and then dragged her body out of her vehicle dumping it in the K & W parking lot at which time they took her vehicle and fled the scene, all as witnessed by another individual in the parking lot. Investigation revealed that they then drove the Victim's vehicle to their motel where they got their luggage and loaded it up thereafter leaving in the truck of the Defendant Freeman and the Victim's car. At 4:06 pm, they burned the Victim's car in North Carolina and again fled the scene in the presence of another Witness. Defendant Freeman has at least one prior conviction for a Violent Offense.

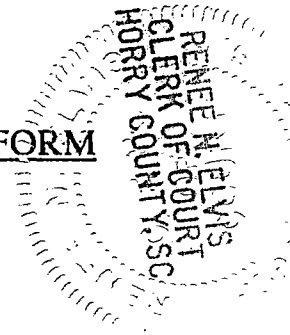
