


This case was tried before the Honorable Frank R. Addy, Jr. and a jury beginning on April 10, 2018.

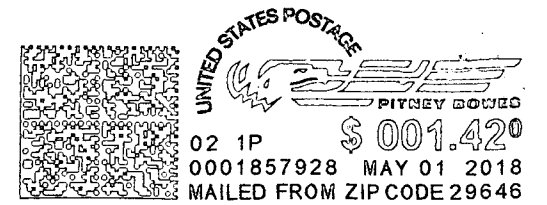
