



1. The Court improperly awarded pre-judgment interest from a date prior to the demand, see Babb v. Rothrock, 310 S.C. 354, 26 S.C.2nd 789 (1993).
2. The Court erred in awarding costs that were not taxable by statute or pursuant to Rule 54(e), SCRPC.
3. The Court erred by including findings of fact completely unsupported by any evidence entered at trial.



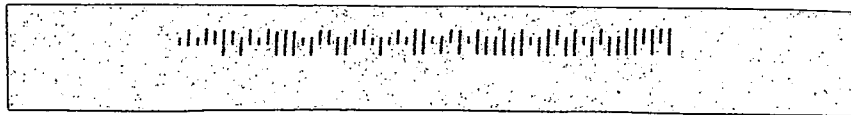
