Why am I'm still here your honor? Then that search warrant is the reason why my prelim was waive. The state never show that probable cause exists. 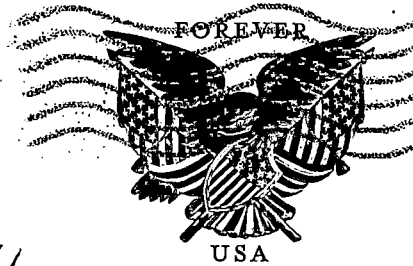
