**JOINT MOTION FOR EXTENSION  
OF TIME TO FILE PETITIONS FOR REHEARING**

Pursuant to Rules 240 and 263(b) and of the South Carolina Appellate Court Rules, all parties to this appeal respectfully request an additional fifteen (15) days to file any Petitions for Rehearing, to June 1, 2018. The parties submit that there is good cause for this extension, as follows:


1. The Court filed its opinion in this case on May 2, 2018.

2. Simultaneous with its opinion in this action, the Court issued similar rulings in two other related actions: *The Callawassie Island Members Club, Inc. v. Michael J. Frey and Grace I. Frey*, Appellate Case No. 2015-000002; and *The Callawassie Island Members Club, Inc. v. Mark K. Quinn and Sherry B. Quinn*, Appellate Case No. 2015-000003.
3. Pursuant to S.C.A.C.R., Rule 221(a), the parties must file any Petitions for Rehearing within fifteen days after the filing of the Court's opinion, *i.e.*, on or before May 17, 2018.
4. All parties request an additional fifteen days, to June 1, 2018, to file any Petitions for Rehearing.
5. The reasons for the request are (a) the complexity of issues and law in the Court's opinions, some of which favor and disfavor the various parties, (b) the length of the record on appeal which needs to be reviewed, and (c) that all parties are attempting to coordinate responses in the three related cases involving Callawassie.

Therefore, the parties respectfully ask this Court to permit all parties until June 1, 2018, to file any Petitions for Rehearing.
