MOTION FOR AN EXTENSION OF TIME

TO: THE S.C. SUPREME COURT ET. AL.,

THE HONORABLE COURT GAVE THE PETITIONER UNTIL NOVEMBER 22, 2017 TO SUBMIT HIS PETITION AND APPENDIX. UNFORTUNATELY, DUE TO CIRCUMSTANCES BEYOND MY CONTROL. THE PETITIONER IS FORCED TO MOTION FOR AN EXTENSION OF TIME OF (10) ADDITIONAL DAYS. THE PLEADINGS ARE READY. ITS BEEN READY SINCE NOVEMBER 15, 2017. YET, THE SITUATION ARISES WHERE THE INSTITUTION IS LOCKED DOWN AND THE CANTEEN IS OUT OF YELLOW ENVELOPES THAT WOULD ALLOW

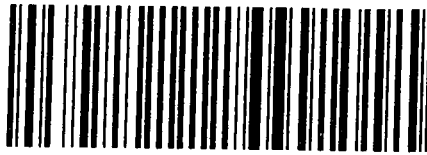

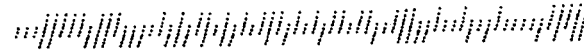
