RESPONDENT’S MOTION FOR AN EXTENSION OF TIME

Respondent Avtex Commercial Properties, Inc. hereby respectfully requests this Honorable Court for an additional extension of twenty (20) days from the existing deadline to file its Return to Appellant’s Petition for Writ of Certiorari in the above captioned matter. 
