Appellant's Motion for Extension of Time





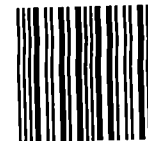
