STATEMENT OF COSTS**





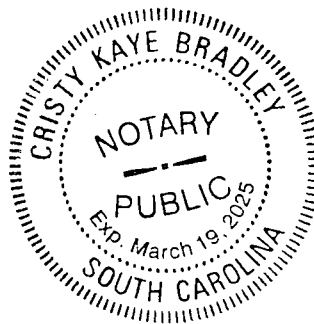
