
Dear Mr. Sumner:

I hereby acknowledge receipt of your request for transcript dated May 15, 2018 in the above-captioned case held in front of Judge Young on January 22 - February 2, 2018. I have reviewed my records and estimate that your transcript will be 1,925 pages. Based on the current rate of \$3.25 per page, the cost will be \$6341.25, which includes Keyword Indexing and PDF e-mail delivery.
