
I am writing to respectfully request protection with regard to the above-referenced case from June 18 – July 20, 2018 for a planned and pre-paid family trip to Africa.

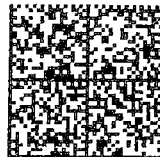
