On May 18, 2018, the Appellant was convicted of Armed Robbery (Indictment No.: 2015-GS-10-00054), Kidnapping (Indictment No.: 2015-GS-10-00055), and Assault & Battery of a High and Aggravated Nature (Indictment No.: 2015-GS-10-00053). The Appellant received a sentence of Thirteen (13) years on Indictment 2015-GS-10-00053, and Ten (10) years on Indictment 2015-GS-10-00054 and Indictment 2015-GS-10-00055. All sentences are ordered to run concurrent.




