Appellant is a prisoner within the South Carolina Department of Corrections and has appealed a disciplinary hearing decision before the Administrative Law Court pursuant to Al-Shehbaz v. State, 338 S.C. 354, 527 S.E.2d 742 (2000)

Honorable Deborah Brooks Durden, an Administrative Law Court Judge, signed a "Order of Dismissal, (With Prejudice) dated May 9, 2018, regarding the matter herein appealed ..., And this "Notice of Appeal," follows:

Appellate alleges the Court, (ALC) findings was based on incorrect & misleading information as it concerns appellant's loss of good time credits. Secondly, appellant argue that substantive, (Constitutional) rights were abridged and the Court's finding resulted in a erroneous decision as a matter of law.

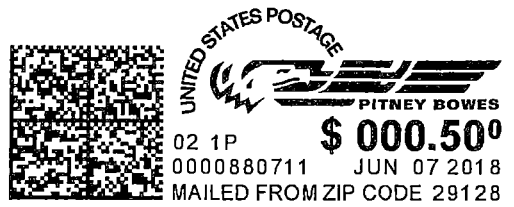
