
As noted in our April 26, 2012 filing letter, enclosed with Georgia Pacific's notice of appeal, Del Webb Communities, Inc., an Arizona Corporation, filed the first notice of appeal arising out of the case below making it the primary appellant under Rule 206, SCACR. Del Webb filed its notice of appeal on April 2, 2012. This letter is to inform you of both notices of appeal in this matter. The appeals should be consolidated for the purposes of adjudicating the appeals because both appeals arise from the same case at the trial level and the issues on appeal are related.
