
NOTICE OF CROSS APPEAL



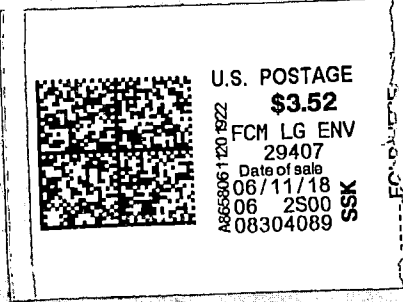
