



Motion for Appointment of Counsel

In Court Judge Hall on May 8, 2018 was very clear in Court that he felt that due to the medications prescribed to me by my Doctors due to the Stalking, Terrorizing, and Trauma buy Mike Davis and his confederates I have had to endured and the reason I have to take these medications I was in a state he could not understand and I would not be able to present my case to a Jury I Had Demanded as of Right.

I take urine test to assure I do not drink alcohol nor do any drugs not prescribed by my doctors.

If I am so unable to present my case then Judge Hall should have appointed me a Lawyer to protected my Constitutionally Protected Rights and to present my properly Filed and Served Constitutional Challenge

On May 7, 2018 hearing after seeing the Proof of Crimes by the Government which started this case and my meeting of Mike Davis, Judge Hall said he would require Andrea to testify in court even with the collaboration of the Defendants Lawyer and the Federal Government.

I have included 2 Documents showing the increased Trauma Caused by Mike Davis even before we got him convicted of State Stalking Charges which he ignored and still beat.

Mike Davis had broke into our apartment on May 4, 2014 through the window and stood over my bed as I slept. I woke while he was trying to smash my roommate's door open. It only got worse from there.

When I started seeing the Doctor because of Mike Davis's Stalking it was on June 9, 2015. It took a long time to get Fetter Health Care's referral to Compass Health Systems with my Disability insurance. My first visit is Page 79 of 81. Having panic attacks daily. Recent situation with a man stalking him and his roommate. Panic attacks have increased trying to manage that situation....**and that he is very afraid of what this man might do.** At this point I was diagnosed

with **“Panic disorder without agoraphobia”**. Mike Davis got worse and worse with his stalking. Cutting bike tires and more. (Documents included)


Because of the Defendants lawyer I was able to get these Documents. On page 1 or 81, July 31 2017 it states **“Still having vided nightmares regarding Mike Davis and frequent Panic attacks”**. My diagnoses had increased at that time to **“Panic disorder with agoraphobia and moderate panic attacks”** and **“Post traumatic stress disorder”**. (Documents included)

By the time we got to Court with all of The Defendant’s lawyers extensions and postponements, by May7, and May 8, 2018 I am at the point I can hardly function normally from the Trauma and I still have to go to regular therapy and my medications have been increased.. But that does not mean I do not have the same Constitutionally Protected Right to have me grievance heard as a person who has not had to endure years of Terror and Trauma.

Judge Hall said it was Dismissed per SCRCB B (Big B). Even though I cannot find this Rule in the list of Rules I did Challenge it in my properly filed Constitutional /challenge that was never heard by the Jury as I Demanded.

For this reason I Pray this Court appoints me a Lawyer to protect my Constitutionally Protected Rights.




