I, Theodore Wagner file this complaint against the above named defendants for damages for mental anguish and slander, etc. for; Conspiring with Designa Print INC, and Michael Davis who Owns Design-A-Print INC , for Internet Stalking to cause harm and spread lies about me; Stalking and Terrorizing me in any manner he can find; breaking into my home and entering my bed room while I was sleeping; Spreading lies that I am a homosexual to homeless men that he picks up for sex, and to other people; for the fear for my life and terror I have felt for a year and a half because Mike Davis' Stalking. As of today, July 22, 2015, Mike Davis now has General Sessions Charges for Stalking to go along with pleading guilty for stalking in the City of Charleston.

These are part of the Chronology of Michael (Mike) Steven (AKA Ricky) Davis' Staking of Aaron Satcher given to Prosecutor Lucka in the case that Mike Davis plead guilty to Stalking Aaron Satcher. These are given to show motive of why Mike Davis has turned his Stalking toward me and why I now live in fear when I am in my own home, walking out of my apartment, or traveling any where at any time on the streets. I have to go to a psychiatrist now for the stress and trauma. I have spent over a thousand dollars on surveillance equipment to try and help protect Aaron and myself from Mike Davis. The surveillance videos included as evidence with this complaint show Mike Davis putting up one of his slander posters on our stairway and then coming to remove it after being caught by Aaron at 3:50 am., July 19<sup>th</sup> 2015.

On **March 21, 2014** Aaron tells me he does not feel right about his relationship with Mike Davis. Aaron said he was going to tell Mike later that day that he just wants to be friends. Aaron told me that he had got involved with Mike because Mike would bribe Aaron with lots of cocaine and pot to go to his house in Summerville. He said the first time Mike got him so drunk that he blacked out, Aaron remembered bits and pieces of Mike messing with him. I ask Aaron why he kept going back around Mike. Aaron told me it was because Mike would always tell Aaron he had cocaine and pot at the house

and he can't afford to buy it.

On **Sunday, March 30<sup>th</sup> 2014** Aaron comes running in our apartment about 45 minutes after he had left for church. Aaron said that while Mike was giving Aaron a ride to church, Mike tells Aaron that he had something to tell him. He had called Aaron's parents and told them that Aaron and he had been romantically involved. Aaron was very pissed off yelling that Mike had called Holly trying to break them up. Aaron said that Mike was trying to get back at him for telling Mike he was never going to have sex with him again but they could stay friends. Aaron was yelling at me that he never wants to see or talk to Mike again. Aaron told me that if Mike comes to the house he wants me to run him off.

**March 21, 2014 am**

*Aaron tells me that he wants to end relationship with Mike.*

Aaron tells me that he wants to end his relationship with Mike Davis and only wants to be friends. Aaron tells me how much he cares for Holly and that he plans to move out when Holly when she graduates in a few months.

**March 21, 2014 pm**

*Aaron tells Mike he no longer wants to be anything but friends.*

Aaron goes off with Mike and tells me before he leaves that he is going to tell Mike that he does not feel right about their relationship and only wants to be friends. Within hours Mike is calling Aaron's Mother in the early morning hours to revengefully try to turn Aaron's parents against him. Aaron did not find out about this until March 30<sup>th</sup>.

**May 4, 2014 4:00 am**

*The Break In*

At 4:00 am I am awoken by Aaron yelling "Theo! Theo! Get up! Mike just broke into our house!" I got up to find the front window I had screwed open about 6 inches all the way open and Aaron yelling that he had just seen Mike Davis take off out of the window. Aaron refused to go out and check and ran to the back of the apartment. I took off out of the door and ran down to the intersection looking in all directions. After several minutes of looking I see someone who looked like Mike running to get into a minivan down the street. I took off running in bear feet. I got to the car as Mike was trying to get away. I started beating on the window of Mike's minivan yelling "You broke into my house!" Mike said he just wanted to talk to Aaron and he turned the van around and drove off. As he was passing Mount Pleasant Street he turns and pulls up to our apartment taking off up the steps to my apartment. Aaron had locked the door and would not open it. Mike and I were outside for a while before Mike took off saying he thought Aaron had called the police and they were coming. When Aaron finally opened the door he said he had not called but had run to hide because he thought Mike was going to make good on his treat to kill him. I tried to get Aaron to call the police but he would not. He just wanted Mike to go away and leave him alone.

**May 4, 2014 5:52 am**

*Audio*

Mike's cousin Shain Cooper calls to see if we had called the police to turn Mike in for breaking into our apartment. Shain called at 5:52 am. Less than 2 hours after Mike Davis broke into our apartment. Shain's phone number is 803-553-3654.

May 6, 2014 7:35 pm

Video

Mike at our front door refusing to leave. This is after Mike broke into our house. I had to jam my foot in the door to keep Mike Davis from home invasion.

May 6, 2014 7:44 pm

Audio

Mike Davis calls again to say he will not call again and he appreciates that we did not call the police. Mike said he will never *scare* Aaron again and he was sorry for all the people he has hurt. I don't see how Aaron hurt anyone while excising his Unalienable Right of Free Will. By braking into our house he finally believes that Aaron and I are not involved in an intimate relationship. He said he will leave Aaron alone and never call again. **Liar!**

May 7, 2014 7:24 am

Video

Went with camera to video Mike stalking Aaron on Rutledge Avenue going to work. Mike tries to leave when he sees that I have the video recorder with me. Aaron again over and over says on the video that he wants nothing to do with Mike and does not want to have any type of friendship with him.

June 16, 2014 4:00 pm

Officer Vogus informs Aaron at work of Mike's treat.

Aaron called me at home to tell me that Officer Vogas had come to his work to warn him that Mike Davis had told his counselor that he could not stop thinking of killing Aaron. The counselor informed the police and Officer Vogas said the police had to pass the warning on to Aaron. Now Aaron is really stressed out.

June 24, 2014 1:06 pm

Video#1 Mike still stalking

About 12:30 pm Aaron and I went to the library to use the computers. As we are going up the downstairs steps from the first floor I notice Mike Davis coming down the steps. Aaron did not notice him. When I said I saw Mike Aaron wanted to call the police. I ask him why. Mike left. We continued up to the third floor to use the computers. While we were up there Aaron comes running up to me to tell me that Mike Davis had walked within about 15 feet of Aaron and looked him in the eye. Aaron was in a panic. I see Mike Davis looking over his shoulder as he ran to the elevator and then to the stairs. (At this point Mike Davis had already violated the restraining order when he came all the way to the third floor to look Aaron in the eyes. The police had already come to

Aaron on **June 16, 2014** to warn Aaron of a viable threat of his life. This is a form of using the courts and law enforcement to make indirect contact with Aaron and cause him panic). I told Aaron that if he was still downstairs when we left we would call the police. When we walked downstairs Mike Davis was talking to the police. They stopped us at which time I gave the police officers the court ordered restraining order from **June 3, 2014 8:30 am. Amended Consent Order**. I told the officers that Mike Davis had followed us upstairs and I wanted him arrested for violating the restraining order. Officer – said he would not.

Aaron was freaking out so we left while the police were still talking to Mike. Aaron and I walked down to East Bay Street and turned toward Broad Street. I was walking my bike because Aaron did not have one. As we got to the corner of East Bay Street and turned right, Mike Davis slowed his van, headed north, at the corner of Calhoun and East Bay honking his horn and waving with a big grin on his face. Little did we know he was going to turn around and stalk us all the way to Broad Street.

**June 24, 2014 1:29 pm**

Audio Aaron calls Prosecutor Lucka

Aaron calls Prosecutor to tell her what Mike Davis just did.

About 1:00 pm Aaron and I had just left the Broad Street Barber Shop trying to get a haircut for Aaron. As we crossed Meeting Street to the bus stop benches Aaron says, "There's Mike right behind us!" in a total panic. As I look across the street I see Mike on the other side of the street where we had just been. I took my video recorder out just as the bus pulled up. I videoed Mike Davis before and after we got on the bus. Aaron text-ed prosecutor Melisa Lucka . She text-ed back and said to call 911. By this time the bus had passed the Market and Mike Davis. I told Aaron that Mike was now behind us and to wait to talk to prosecutor Melisa Lucka in person.

**June 24, 2014 2:14 pm**

Audio Aaron calls Prosecutor Lucka

Aaron calls Prosecutor Lucka from the bus to find out what to do about Mike.

**June 24, 2014 2:16 pm**

Aaron text Prosecutor Lucka

She said to call the police but we were all ready on the bus heading home.

**June 26, 2014 1:30 pm**

Went to the police station to see Prosecutor Lucka.

Prosecutor Melinda Lucka was not there. We gave a copy of this paper to Prosecutor Mark Bourdon. He said he would get in touch with Prosecutor Lucka in the morning.

**July 1, 2014 7:00 am**

Bicycle tires slit

See police report

I came out at 7:00 am to catch the bus with my bike to find both

tires flat. I got the tire pump to pump them up. Both tires were slit. My bike is on the upstairs porch so someone had to go out of their way to do this. Two months ago someone slit both of Aaron's bike tires. I called the police to make a police report.

July 3, 2014 10:00 pm

Noah comes over to say he saw who slit my tires.

Around 10:00 pm, my nabor Noah comes over and knocks on the door. Our nabors don't usually talk to us. The day my bike tires got slit I ask his girlfriend if she saw anything. She said no. Noah said that she had just told him about it and he believed he saw it happen. Noah said about 2:00 am, he was sitting in their porch chairs when he saw a man come up the stairs and mess with my bike. He heard a hissing sound while the guy knelled by my bike then he left. I got Aaron to come out and show Noah a picture of Mike he had on his phone. Noah said it was the same guy he had seen that night. I ask if he would talk to the police which he said he would. I called the police immediately to tell hem I had found a witness.

July 3, 2014 1:00 am

Aaron receives phone call from restricted number.

Aaron would not answer the call. He said he never receives restricted numbers so he is sure it was Mike.

July 13, 2014 10:00 am

Audio I called Prosecutor Lucka

I called Prosecutor Lucka to remind her that we need the video from the library because they will not let us have it without a court order. I gave her my phone number. I was clear that Mike Davis has put me in harms way when he gave the false police report on **June 24, 2014 1:06 pm**, and that Aaron and I do not want to let it go. I also told her about finding Noah in the last apartment who witnessed Mike messing with my bike at 2:00 am. Lets see if she calls.

Sept. 11, 2014 8:30 am

Bicycle tires slit      See police report

I came out at 8:30 am I came out to find that my bicycle tires were slit.

Sept. 11, 2014 7:30 pm

Richard from downstairs came up to tell me that he had seen Mike Davis running from our apartment with white gloves on running toward the store behind our apartment. Richard was once a friend of Mike's and knew him well.

May 29, 2015

**Mike Davis conspired with Designa Print to stalk me and call me a homosexual with Malice and Forethought.**

Yesterday Aaron registered his bike and we got the **Final Disposition** on Mike Davis' court hearing. We also got an Facebook message he received from a friend of his Colt Protheroe and a recorded phone call from Keila Castillo. Mike Davis has contacted several of Aaron's friends telling them that I am a Rapist and how to look me up on the internet. He is also stating that Aaron and I are lovers. I will sue him. I need to go to my psychiatrist now for the trauma I feel from that. Mike will not stop and Aaron is to financial unstable to fight him to do anything about it. (See Exhibits.)

Under U.S. federal law, someone commits the felony of stalking if that person: (18 USC § 2261A.)

- causes, attempts to cause, or could reasonably be expected to cause substantial emotional distress to the target of their conduct. (See Exhibits)

**On June 19<sup>th</sup> 2015 Aaron Satcher and I both Filed formal complaints with the Cyber Division of the FBI to file a formal complaint of the Cyber-stalking by Mike Davis and Designa Print.**

Thank you for filing a complaint with the Internet Crime Complaint Center (IC3).

SC Code § 23-3-510 (2012) A person who commits a criminal offense using information from the sex offender registry disclosed to him pursuant to Section 23-3-490, upon conviction, must be punished as follows:

(1) For a misdemeanor offense, the maximum fine prescribed by law for the offense may be increased by not more than one thousand dollars, and the maximum term of imprisonment prescribed by law for the offense may be increased by not more than six months.

(2) For a felony offense, the maximum term of imprisonment prescribed by law for the offense may be increased by not more than five years.

**July 19; 2015 3:50 am**

Mike Davis Trespasses at my apartment to put up a poster as to facilitate this Ongoing Conspiracy. If Aaron had not been out partying where he came across **Mikes' Dodge Caravan license number CVN-775** on Darlington Avenue, the Lies and harm of the poster that Mike Davis went to the trouble to violate a court order to put up in our stairwell would still have been there in the morning. **July 23, 2015**

We received a call from the police that Mike Davis had been arrested at his parents house on General Session Charges for this Ongoing Conspiracy of Stalking and Terror he has caused for a year and a half.
