THIS GREAT STATE WITH A SENSE OF CAMARADERIE  
TOWARDS US ALL WORKING TOWARDS A COMMON GOAL; THIS  
BEING TO CORRECT A GROSS MISHANDLING OF MY CASE FROM  
THE START.

I TURNED FIFTY YEARS OLD IN PRISON, NEXT MONTH I TURN  
FIFTY FIVE AND I FEEL I AM AT A CROSS ROADS IN THIS LIFE.  
WHEN THE INCIDENT HAPPENED MY MACHINERY AND EQUIPMENT  
BUSINESS SHUT DOWN AS A RESULT OF THE TV NEWS  
COVERAGE ANNOUNCED AFTER INFORMATION WAS WOVEN FROM  
A SPINNING WHEEL INFLUENCED BY THE VICTIMS IN MY  
CASE FAMILY AND FRIENDS, WHO CONTINUED TO RANT, RAVE  
AND INTIMIDATE ME, MY FAMILY AND IN MY OPINION  
THE COURT IN YORK COUNTY, AS WELL AS MY LAWYER.  
KEY FACTS THAT SHOULD HAVE BEEN INVESTIGATED AND  
WITNESSES DEPOSE WERE IGNORED FOR TRIVIAL AND CHILDESH  
RED HERRING GOSSIP TO COVER UP OBVIOUS CHARACTER TRAIT EXPOSING  
THE ILLEGAL BUSINESSES AND LIFESTYLES OF BOTH VICTIMS  
EVIL AND DANGEROUS EXISTENCE. I HAVE SUFFERED GREATLY

HIGH SCHOOL SHOOTER IN FLORIDA WOULD HAVE REACTED HAD HE  
EACH ARMED TEACHERS OR STAFF?
